Sub.: Temporary approval of affiliation of Faculty of Law, The Glocal University, Behat, Saharanpur, Uttar Pradesh for 3 year LLB, 5 year BA. LLB & BBA. LLB law courses.

Sir,

Legal Education Committee at its meeting held on 25th / 26th May, 2013 considered the inspection report of the above mentioned college and Committee made the following recommendations:-

The Legal Education Committee considered the recommendation of the Standing Committee. After consideration, the Committee finds that the Glocal University, Saharanpur, U.P and its Faculty of Law University has applied for 3 year LL.B course, 5 year BA LL.B and five year B.Sc. LL.B course. Thereafter the University has informed that by clerical mistake instead of BBA.LLB it was written B.Sc.LLB in the application form. The letter was placed before this Committee and noted. So far 3 year LL.B course, five year BA.LLB course and 5 year BBA LL.B course is concerned, the Committee finds that there are only three teachers for non-law subjects in the list of faculty members, two M.A. in Sociology and one M.A. in English for BA.LLB and one professor having MBA degree for BBA.LLB

subject teachers in other two subjects within six weeks and two more MBA degree holder for BBA.LLB course. The appointments should be made within a period of six weeks after proper constituting a selection committee and intimation should be sent to the Bar Council of India through affidavit within the same period for further confirmation of the Bar Council of India.

Further the Committee is of the view that as per Section 7 (1) (i) of the Advocates Act, 1961 University be granted recognition for the purpose of conferring the degree of law for imparting three year LLB, five year BA.LLB course and five year BBA. LL.B course and also granted temporary approval of affiliation for its Faculty of Law, Glocal University to impart three LLB course, five year BA.LLB course and five year BBA.LLB course with two sections of 60 students in each section in each course for a period of two years from the academic year 2013-14 to 2014-15 subject to the following conditions.

1. The management of the University is directed to furnish the approval of the University Grants Commission before starting the admissions.
2. The University management is directed to establish the Legal Aid Centre as per Clause-11, Schedule-III of Rule-11 of the Part-IV of the Legal Education Rules - 2008.
3. The University should ensure the payment of salary to teachers as per Rules 22 schedule III, Part IV of BCI Rules.
4. The institution is directed to upgrade the library by investing Rs.50,000/- per year per stream by purchasing Law books/journals and AIR and other materials.
5. Teacher Student ratio shall be as per Schedule-III, Rule-11, Clause-17, Part-IV of Bar Council of India Rules.
6. To ensure that students are given full opportunity to participate in National Seminars. Moot etc.

The above recommendations were considered by the Bar Council of India at its meeting held on 27th May, 2013 and accepted the same.


The college shall also comply with the following Rule of the Bar Council of India (Clause (iii) and Explanation 2 of Schedule IV in Part IV of new rules of the Bar Council of India):-

"Whenever approval of affiliation is granted to the Centres of Legal Education, it shall be necessary for the Centres of Legal Education to deposit Rupees Two Lakh in shape of guarantee to fulfil all the norms of the Bar Council of India. The same shall be liable to be forfeited if norms are not complied with and same shall carry no interest."

The approval of affiliation now granted by the Bar Council of India is subject to the payment of guarantee amount as mentioned in the above rule.

College authorities are also required to apply to the Bar Council of India for further extension of approval of affiliation six months in advance before expiry of the period of approval of affiliation granted by the Bar Council of India i.e. on or before 31st December, 2014.
